Lesson Conditions (for safety of all involved)

1. Do not leave any unattended children on the property. Unattended children (under 16 years old) will be given hay and water and a boarding fee of \$1 per minute, per child will be charged.
2. While adults are receiving lessons, arrangements must be made for any accompanying children (see point one).
3. Parent or guardian may leave the property, but cannot leave an unattended child waiting for a lesson. If you do not return before the lesson is completed, therefore leaving an unattended child, point #1 applies.
4. Your attendance at riding lessons does not give freedom to roam the property. Everyone must remain in the riding ring area or barn area.
5. There is no feeding or petting of other horses on the property. Petting of dogs or cats is at your own risk. No personal animals (pets) are allowed out of your vehicle.
6. There needs to be a 24 hour notice given (phone message acceptable) for any cancelled appointment or you will be charged for the lesson. Zakar reserves the right to be lenient for any specific situation.
7. Lesson fees need to be paid in full in advance.
8. When purchasing a lesson package Zakar assumes responsibility to reschedule a cancelled lesson only once. A rescheduled lesson is considered completed and will be deducted from the lessons remaining even if it is not actually attended. Rescheduled lessons must be arranged & completed within a week of the original date, Zakar reserves the right to plan that rescheduled appointment beyond the week timeframe.
9. Your lesson is your responsibility. If you are late arriving, your lesson will end on time.
10. If Zakar is late your full lesson time will be completed. Horses are willful animals and therefore at times lessons must be extended to spend essential “teachable moments” instructing. Please be considerate and flexible to accommodate this.
11. If you would like to have other siblings take a “pony ride” at the end of your scheduled lesson, please let me know at the start of the lesson. Your child’s lesson will end 10 minutes early for the purpose of readjusting the saddle and helmet and the leftover time will be the pony ride. The lesson will end on time.
